

Business Visa

- Passport valid for 6 months (**Copy of the Passport - 2 copies of first page on a separate sheet, one copy of last page**)
 - Form has to be filled online at <https://scedv.serpro.gov.br/frscedv/index.jsp>
 - 2 Recent Photos on white background, size - 35mm x 45mm with 80% face image (*Photographs should not be old for more than 6 months*)
 - Invitation with full details [brief history about co. name of PAX and designation and purpose of visit with day to day schedule and declaration clause]
 - Covering Letter on Company Letter Head with full details [brief history about co. name of PAX and designation and purpose of visit with day to day schedule]
 - Return Ticket with ticket number
 - Personal Income Tax Paper of last 3 years
- Personal Bank Statement of last 3 months

Tourist Visa

- Passport valid for 6 months (**Copy of the Passport - 2 copies of first page on a separate sheet, one copy of last page**)
- Form has to be filled online
- 2 Recent Photos on white background, size - 35mm x 45mm with 80% face image (*Photographs should not be old for more than 6 months*)
- Covering Letter and Leave letter from Company
- Hotel Confirmation
- Return Ticket with ticket number
- Personal Income Tax Paper of last 3 years
- Personal Bank Statement of last 3 months

Work Visa

- Passport valid for 6 month (**Copy of the Passport - 2 copies of first page on a separate sheet, one copy of last page**)
- 2 Visa application form [Online forms]
- 2 Recent Photos on white background, size - 35mm x 45mm with 80% face image (*Photographs should not be old for more than 6 months*)
- Covering letter on Company Letter Head
- Original Police Clearance Certificate

- Approval for work permit from Brazil immigration
- Letter from the Indian Company addressed to the Consulate requesting for visa.
- For Children below 7 years, polio vaccination certificate is required
- A person under 18 years of age not travelling with both parents or legal guardian(s) must provide a **Notarised Form** (available at Consulate) of consent signed by the non accompanying parent or guardian, attested by Mantralaya. **The Consulate will then legalised the document. A Fee of Rs. 1200/- will be charged in the form of Pay Order (Mumbai)/Demand Draft payable at Mumbai in the name of "Consulate General of Brazil."**

Visa Fees

- Rs. 2,400.00 by draft favouring "**CONSULATE GENERAL OF BRAZIL**" for Tourist Visa
- Rs. 4,800.00 by draft favouring "**CONSULATE GENERAL OF BRAZIL**" for Business Visa
